Mayor Morgan called the meeting to order with a salute to the flag and in accordance with the Open Public Meetings Act by advertising notice of meeting in the N.J. Herald and posting copy of notice in the Borough Hall.

#### OATH OF OFFICE:

The Municipal Clerk administered the oath of office to Mr. Michael Figueiredo. This seat is an appointment filling the vacancy left by Mrs. McGowan and is for one term to 12/31/15. The seat is eligible to be filled at the next general election for one term to 12/31/16.

#### **MINUTES:**

A Motion was made by Mr. Smith, seconded by Mrs. Delfing to approve the minutes of the meeting of the Mayor and Council held on January 21<sup>st</sup>, 2015 as per copies furnished to each member. #### **CORRESPONDENCE:**

Sussex Board of Taxation re: Preliminary Equalization Table was reviewed and filed.

NJ Bureau of Water System Engineering re: Inadequate Water Supply was reviewed and filed.

Andover Twp. Assessor re: 2014 Assessment Card blk 166 lot 2 Q0037 was reviewed and filed.

NJDEP Compliance & Enforcement re: Water Quality Compliance Inspection # SCI 150001 was reviewed and filed.

AUDIENCE PARTICIPATION: Mr. Stephen Verbesky who is part owner of the Andover Hunt and Fish located at 196 Main Street asked the Council if the water bill could be calculated using the meters. Mr. Smith explained that the water amounts are set by ordinance as a flat rate. He continued to say that of the three existing stores there, two stores were combined so Mr. Verbesky could indicate to the zoning board that he now has two stores instead of three and therefore could reduce the number of commercial water bills down to two. This would be a cost savings of \$420 per year.

# **REPORTS OF SPECIAL COMMITTEE:**

Mr. Jim Landrith reported for SWAC. He reported that Grinnell in Sparta is no longer operating to accept the Sandy Recovery material and is farming it out. He continued to discuss the additional bulk materials they are working to accept in addition to asphalt. SWAC is also review the water quality reporting, by hydro geologist Dave Moskato. Mr. Landrith reported that the DEP deemed development qualifies for 4.5 acres size for septic.

# **REPORTS OF STANDING COMMITTEES:**

Administrative & Executive: The Board of Health would like to have a filing cabinet. A cabinet could be moved to a location downstairs for them. The Municipal Clerk is continuing to organize the office. The Mayor asked if the Administrative Committee could start looking at the ordinances and start with the commercial truck /parking ordinances.

<u>Celebration of Public Events:</u> The Miss Andover Pageant / Princess Pageant will be held on June 8<sup>th</sup> at a Council meeting if there are any applicants. The Memorial Day wreath ceremony is planned for 10 a.m. and the Easter Egg Hunt is already planned.

Finance: Mr. Dennison reported that the budget introduction is scheduled for this evening.

Parks & Playgrounds: Mr. Danielson reported that the fields use requests are scheduled.

**Public Bldgs. & Grounds:** Mr. Smith reported that the roof of park building is being checked. The property owned by Andover Borough will be leased again to the farmer from last year. That paperwork is with the Borough Attorney.

Public Safety: Mrs. Delfing reported that the inspection of the ABFD is still planned.

**Streets & Roads:** Mr. Danielson reported that there are some roads which are caving and heaving from the temperatures this winter. He will call the County to review possible ways to fix. Old Creamery still needs to be reviewed for widening and repair.

**Water Utility:** Mr. Smith reported that he would like to purchase a backup chlorinator. The water softener from Culligan may also need to be reviewed for replacement. He also reported that a number of heaves in the roads and tunnel were noticed after this winter.

Mr. Danielson reported that there is no news on the Engineers review of the water runoff on Morris Sussex Trnpk.

# AN ORDINANCE TO AMEND CHAPTER 66, ENTITLED "FEES", OF THE CODE OF THE BOROUGH OF ANDOVER, COUNTY OF SUSSEX, STATE OF NEW JERSEY, ESTABLISHING FEES FOR VITAL RECORDS

**BE IT ORDAINED** by the Borough Council of the Borough of Andover, County of Sussex, State of New Jersey, that Chapter 66 of the Code of the Borough of Andover, entitled "Fees", be and is hereby amended as follows:

**Section 1.** Section 66-4, entitled "Miscellaneous fees and charges" of Chapter 66 of the Code of the Borough of Andover, entitled "Fees", be and is hereby amended to add new subparagraph F as follows:

F. Vital records fees are as follows:

Marriage license application	\$28
Domestic partnership application	\$28
Civil union license application	\$28
Remarriage license application	\$28
Certified copy of vital record	\$10
Certification for burial permit	\$ 5
Correction of vital record	\$25

**Section 2.** Severability. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.

**Section 3.** Repealer. All ordinances or parts of ordinances or resolutions inconsistent with or contrary to the provisions of this Ordinance are hereby repealed to the extent of such inconsistency or contrariness. All provisions of Chapter 66 of the Code of the Borough of Andover, entitled "Fees", not amended hereby shall remain in full force and effect.

**Section 4.** This Ordinance shall take effect immediately on its final passage and publication as required by law.
