## **Administrative & Executive:**

Mr. Pearson reported that he will continue to fine tune the issues surrounding the new emails. He will be meeting with the Clerk to understand the issues at hand. Also, he has contacted Senator Oroho regarding a bill to amend the bill which addresses the board of health as it pertains to borough towns.

## Celebration of Public Events:

Mr. Figueiredo reported that the Easter Egg Hunt was a success. It was thought that perhaps that the time should be changed to noon next year. Mr. Figueiredo continued to report that the Memorial Day wreath ceremony will be held at 10 a.m. Lastly, the clean community event in the park is scheduled for 5/13/17.

# Parks & Playgrounds:

Mr. Figeuiredo reported that the port-a-john was tipped over and was cleaned up on Tuesday. There was also some discussion about Terry C. doing work in the park. A MOTION was made by Mrs. Delfing, seconded by Mr. Pearson to approve \$200 to pay for this work. Upon roll call the following votes were cast: AYES: Dennison, Figueiredo, Pearson, Smith and Delfing. # **Public Bldgs. & Grounds:**

Mr. Smith reported that quotes are coming in for masonry work and that the A/C is not in yet and may not be before the election in June. He also mentioned that the Senior Citizens would no longer be using the park building for their meetings and also the issues surrounding the rumors for this. After some jovial conversation, it was made clear that regardless of the circumstance, the municipal clerk had no part in the matter that lead up to their leaving or the decisions for the requirements that were presented to them to continue to use the building. In light of this discussion and for the sake of consistency the building in the park will now be referred to as the community center. Additionally he reported that the Generators which have been priced out at about \$36000-40000 but the bidding process and prevailing wage will have to be followed. Lastly, the faucet outside may have an issue and may need to be replaced.

Public Safety: Mrs. Delfing reported that the ABFD Fish and Chips dinner was a big success.

## Streets & Roads:

Mr. Hoag was absent. It was mentioned that the catch basin on lower Maple was repaired and that street sweeping was done.

# Water Utility:

Mr. Smith reported that the pump house has been weed whacked and the first quote to install an m-scope came in around \$4000. As per the notice he has received that there are no meters left, the water department will not be purchasing any more meters. There was also a brief discussion regarding the DBRC submission needing to be redone. The Mayor reported that Mr. Copcutt will be moving again, but remain in Tennessee.

#### **NEW BUSINESS:**

The Council considered the ABFD request to use the ballfield for a drill with Atlantic Health on 6/12/17. A MOTION was made by Mrs. Delfing, seconded by Mr. Figueiredo to approve the use. Upon roll call the following votes were cast: AYES: Dennison, Figueiredo, Pearson and Delfing. NAYS: Smith. Motion carried.
