PREPARATION OF THE 2018 MUNICIPAL BUDGET:

There was a brief discussion regarding the anticipated tax rate and that there would be a better idea once the County and School portions are in. The introduction will be on March 12th.

RESOLUTIONS:

Bond Anticipation Note:

Generator Grant: Review of recommendation of award for proposed standby generators submitted by C. Stoner of H.E. Pellow & Associates, Inc.

Estimate from sign connection for municipal sign were carried to the meeting in March.

Estimate for magnetic valve box locator for water dept. were carried to the meeting in March.

It was reported by the Mayor that he was able to get estimate in for a propane tank at the pump house for the new generator. Suburban Gas \$500 for tank plus \$629 and 2-year contract, Fairclough \$2700 for 1000G and \$627 for 1st delivery, Region \$1000G \$1079 unfilled.

A MOTION was made by Mr. Pearson, seconded by Mr. Figueiredo to go with Region for the tank. Upon roll call the following votes were cast: AYES: Figueiredo, Smith, Pearson, Delfing. NAYS: None. Motion carried.

There was a brief discussion regarding the approval by the State to grant a municipal aid grant for Lindley Court in the amount of \$55,000. Paper work is being prepared,

It was reported that there is a diesel fuel small at block 26 lot 2.01. The Clerk reported that that location is still in need of site plan approval and that a Mr. Clarke Moynihan purchased the property and is operating off the site.

The Water Contract for maintenance and repair is still under review. There were some questions as to how it will be implemented and if more than one can be issued.
