SECTION 1. Section 134-67.3, entitled "Cannabis Cultivators, Manufacturers and Deliverers Prohibited" of Chapter 134-67, entitled "Cannabis, Wholesalers and Distributors", of the Code of the Borough of Andover, County of Sussex, State of New Jersey, is hereby amended to read as follows:

### Section 134-67.3 Cannabis Cultivators, Manufacturers and Deliverers Prohibited.

Cannabis Class 1 (Cultivators), Class 2 (Manufacturers) and Class 6 (Delivery) are prohibited from operating anywhere in the Borough, except for the delivery of cannabis items and related supplies by a delivery service.

SECTION 2. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.

SECTION 3. All ordinances or parts of ordinances inconsistent with or contrary to the provisions of this Ordinance are hereby repealed to the extent of such inconsistency or contrariness.

SECTION 4. This Ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey following the required twenty-day period after adoption, as set forth in N.J.S.A. 40:69A-181(b).

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the

3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Mayor and Council of the Borough of Andover in the County of Sussex finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Mayor and Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$3,861.46 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of Andover, in the County of Sussex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Borough of Andover shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$3,861.46, and that the CY 2022 municipal budget for the Borough of Andover be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

WHEREAS, <u>N.J.S.A.</u> 40:67-1(g) authorizes the governing body of every municipality may make, amend, repeal and enforce ordinances to prevent persons from depositing, material upon any street or highway or portion thereof, or causing or permitting the same to be done; and

**WHEREAS**, the Borough of Andover has determined that passing the within ordinance would more clearly reflect the needs and values of the Borough community; and

**NOW THEREFORE BE IT RESOLVED THAT** Section 7 (Duties and responsibilities of owners and operators) and Section 8 (Duties and responsibilities of non-owner occupants) of Chapter 104 (Property Maintenance) of the Code of the Borough of Andover shall be amended and supplemented to add new Subsections 104-7(U) and 104-8(B) as follows:

#### SECTION 1. § 104-7(U)

**U)** Deposits upon streets and highways. An owner or operator shall not deposit dirt, ashes, leaves or other material upon any street or highway or portion thereof or cause or permit the same to be done.

§ 104-8(B) Deposits upon streets and highways. A non-owner occupant shall not deposit dirt, ashes, leaves or other material upon any street or highway or portion thereof or cause or permit the same to be done.

## **SECTION 2.**

All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

# **SECTION 3.**

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

### **SECTION 4.**

This Ordinance shall take effect after publication and passage according to law.
